



cpi adjustments – operative on and from 1 February 2008

The Consumer Price Index (CPI) for the December Quarter 2007 was released by the Australian Bureau of Statistics (ABS) on 23 January 2008. That index number is 160.1.

The new rates of customs duty set out below are calculated by multiplying the current rates by an indexation factor. This factor is calculated by dividing the most recent index number by the previous highest December or June index number. Accordingly, the December 2007 index number of 160.1 has been divided by the June 2007 index number of 157.5 to establish an indexation factor of 1.017.

Note that these rates are also applied to goods subject to indexation in Schedule 5 (US originating goods) and Schedule 6 (Thai originating goods) in the Customs Tariff.
