CPI adjustments – operative on and from 1 February 2010

The Consumer Price Index (CPI) for the December Quarter 2009 was released by the Australian Bureau of Statistics (ABS) on 27 January 2010. That index number is 169.5.

The new rates of customs duty set out below are calculated by multiplying the current rates by an indexation factor. This factor is calculated by dividing the most recent index number by the previous highest December or June index number. Accordingly, the December 2009 index number (169.5) has been divided by the June 2009 index number (167.0) to establish an indexation factor of 1.015.

Note that these rates are also applied to goods subject to indexation in Schedule 5 (US originating goods), Schedule 6 (Thai originating goods), Schedule 7 (Chilean originating goods) and Schedule 8 (AANZ originating goods) in the Customs Tariff.
